

ORDINANCE 2022-2

AN ORDINANCE AMENDING CHAPTER 13.04.100(C) DELINQUENT WATER BILL CHARGES; INCREASING THE PENALTY OF DELINQUENT ACCOUNTS AND CREATING A GRACE PERIOD.

WHEREAS, The Mayfield Town Council finds it necessary to address the current penalty on delinquent accounts which is 1.5% of the unpaid balance.

WHEREAS, The Town Council feels that this fee is outdated and has evaluated what surrounding communities charge for delinquent fees and how it is assessed.

WHEREAS, The Town Council finds that a penalty of 10% of the unpaid balance should be assessed with a grace period of 5 calendar days.

NOW THEREFORE BE IT ORDAINED by The Mayfield Town Council as follows:

1. Accounts are delinquent when the balance is not paid by the 15th of each month.
2. A grace period of 5 calendar days after the due date (20th of each month) is established.
3. Balances not paid by the 20th of each month will be assessed 10% of the unpaid balance.
4. Mayfield Town Code Chapter 13.01.100 paragraph C. Delinquent Water Bill Charges will read: If any person fails to pay the water charges within 30 days of the date due, the clerk or water supervisor shall give the customer notice in writing of intent to discontinue the service to the customer unless the customer pays the bill in full within five **calendar** days from date of notice. Also, any amount still due after 30 days will be subject to a ~~one and one-half~~ **ten** percent penalty.
5. This ordinance shall take effect upon it's adoption by the Town Council.

Adopted this 9 day of February, 2022, on the motion of Aaron Peterson, seconded by Jaden James.
