

RESOLUTION 2021-G

A RESOLUTION ADOPTING THE STATE OF UTAH'S FIRE RESTRICTION ORDERS WITH THE EXCEPTION OF ITEMS MODIFIED BY MAYFIELD TOWN COUNCIL

WHEREAS, Due to current and forecasted weather conditions coupled with the record dry vegetation conditions and extreme fire danger throughout Town, the Town Council feels that measures must be taken to prevent the ignition of fires.

WHEREAS, The Town Council wishes to incorporate the State of Utah's Fire Restriction order #UTCLO2105 and #UTCLO2102 for all areas inside Mayfield Town boundaries.

NOW THEREFORE, The Town Council hereby resolves the following and prohibits these acts in the area described below until rescinded:

1. No open fires of any kind which use fuel that create sparks or flying embers, except propane fire pits away from dry vegetation.
2. Smoking, except within an enclosed vehicle, trailer or building, a developed recreation site or while stopped in an area that is paved or free from dry vegetation.
3. Cutting, welding or grinding metal in areas of dry vegetation.
4. Operating a motorcycle, chainsaw, ATV, or other small internal combustion engine without an approved and working spark arrestor.
5. Discharging or using any kind of fireworks.
6. The State of Utah Department of Natural Resources Fire Restriction Orders # UTCLO2105 and #UTCLO2102 are adopted and applicable in Mayfield Town.
7. No shooting of explosive targets or ammunition that creates heat or spark, such as tracer & steel core ammunition.

Area Description: All land situated inside Mayfield Town.

Any of the above acts is a violation of state law and is punishable by up to 6 months in jail and a fine of up to \$1,000. These restrictions will be enforced by county law enforcement.

Adopted this 16th day of June, 2021, on the motion of Aaron Peerson, seconded by Eric Peterson. This resolution is effective immediately.

STATE ISSUES STATEWIDE FIRE RESTRICTIONS

Salt Lake City, UT – With record low fuel moisture, widespread drought conditions and extreme fire danger, the State of Utah, Department of Natural Resources, Division of Forestry, Fire & State Lands is enacting statewide stage 1 fire restrictions for all State Lands and all private lands outside of city/town borders. The order is effective starting at midnight tonight, June 10, 2021.

Stage 1 restrictions include a tight limit on where open fires are allowed, and puts constraints on other activities including welding & cutting metal, smoking, etc. (See attached order for specifics)

“As we’ve seen these most recent wildfires, it is clear that fire danger is higher than in any year in recent memory, said Interim Division Director, Jamie Barnes, “although it’s unprecedented and comes earlier than any time in the past several years, it’s absolutely necessary now because current conditions are more indicative of what we’d see during late summer months.”

This order comes following a statewide fireworks restriction issued Tuesday for all state and unincorporated lands. The Division is calling on the public to adhere to the restrictions, bring awareness to them, and report any violations to local law enforcement.

In addition to fire restrictions, the Division and its federal partners are promoting wildfire prevention in a campaign called “Fire Sense”. The campaign focuses on adding a greater sense of fire danger to overall common sense. ORDER # UTCLO2105

Fire Restriction Order

Due to current and forecasted weather conditions coupled with the record dry vegetation conditions and extreme fire danger throughout Utah, the State Forester has determined that measures must be taken to prevent the ignition of forest and rangeland fires. Therefore, pursuant to Utah State Law, Section 65A-8-212, the following acts (also known as "Stage 1 Fire Restrictions") are prohibited **in the areas described below** until rescinded by the Utah State Forester:

1. No open fires of any kind except within established facilities in improved campgrounds or day-use areas on **public lands**. -OR- In permanently constructed fire pits at **permanent private dwellings** served by pressurized running water.
2. Smoking, except within an enclosed vehicle, trailer or building, a developed recreation site or while stopped in an area that is paved or free from dry vegetation.
3. Cutting, welding or grinding metal in areas of dry vegetation.
4. Operating a motorcycle, chainsaw, ATV, or other small internal combustion engine without an approved and working spark arrestor.

Area Description: All state lands –AND- all unincorporated private lands within the state of Utah. This order does not affect private lands within incorporated towns or city limits.

The following persons are exempted from the above prohibitions:

1. Persons with a permit or waiver issued by the Division, specifically authorizing a specified act at a specific location. A waiver does not relieve the permittee of liability if a fire does occur.
2. Any on-duty firefighter in the performance of an official duty.

Any of the above acts is a violation of state law and is punishable by up to 6 months in jail and a fine of up to \$1,000. These restrictions will be enforced by county law enforcement.

Fire Restriction Order

Due to current and forecasted weather conditions coupled with the dry conditions and extreme fire danger throughout Utah, the State Forester has determined that measures must be taken to prevent the ignition of forest and rangeland fires. Therefore, pursuant to Utah State Law, Section 65A-8-212, the following acts are prohibited in the areas described below until rescinded by the Utah State Forester:

1. Discharging or using any kind of fireworks

Area Description:

All state-owned lands -AND- all unincorporated private lands within the state of Utah.

The following persons are exempted from the above prohibitions:

1. Persons with a "Display Operator" license issued by the Utah State Fire Marshal's Office AND any local permits required where the display is to take place.


